20 And I do further and specially authorize
21 and empower my said agent and attorney,
22 to collect and to receive of, and from all and
23 any persons, whomsoever, who may be indebted
24 to me, such sums as may be due and owing to
25 me, and proper receipts and acquittances to
26 give for the same; and to me and apply any
27 moneys which may be in the hands of him my
28 said agent and attorney, in the payment and
29 acquittance of any debts which I may owe to
30 any persons whomsoever; and to me and
31 apply any surplus which may remain in his
32 hands for my use, account and benefit.

And I, the said Courtiers, do
here declare that my Motive in granting
this power is, that, by reason of my longed ill
Health I have not sufficient physical
Strength to give my personal attention
to my business, ~~and~~ I desire to be free
from the annoyances, labor and anxiety in-
cident to active participation in business,
in the hope that I may be, thereby, more speedily
restored to health: and in this view, and
with this hope, it is my intention, and the object
and purpose of this writing, to enable my
Father, as my agent and attorney in fact,
to manage, control and administer for me
and in my behalf, all my property and
business of every nature and kind, as fully to

17 all intents and purposes, and could do any
18 self, were I present and acting in my
19 own proper person, hereby subscribing and
20 confirming all that my said agent and
21 attorney may lawfully do in the premises, under
22 and in virtue of the power and authority herein
23 granted.

24 In faith of which and of the acceptance
25 of the Trust and authority herein granted the
26 Said Vicente ~~Prieto~~ Prieto Jr. and Vicente
27 Prieto, have hereunto signed their names
28 respectively, on this, the 20 day of August,
29 1886, at the above mentioned town of Mandeville,
